BENOWA GARDENS SHOPPING CENTRE - TERMS AND CONDITIONS

1. An entry form may only be distributed by a tenant of Benowa Gardens Shopping Centre when \$20 or more is spent by the customer at a specialty store or \$50 or more at Coles Supermarket in one transaction on any one day. Customers may also enter online by scanning the QR code on the advertising material with a smartphone camera.
2. The Entry Form must be original; no photocopies; scanned images; reproductions or other falsified artwork will be accepted.
3. Customers must attach or retain their purchase receipt as proof of purchase in case they win. They must upload receipt when entering online,
4. The competition commences on Tuesday 31 May.
5. The competition will close on Tuesday 21 June at 9.30am. The draw will take place on Tuesday 21 June at 1pm.
